Background

White Paper to the Danish Parliament on strengthening internationalisation of the education programmes (2004)

Problem

Large number of students from countries outside the EU/EEA enrolled in Academy profession programmes and Professional bachelor programmes

Objective

- Qualifying the demand
- Achieving balance between the wish to attract more international students
- Controlling additional expenditures



Background

White paper to the Danish Parliament about strengthening internationalisation of the education programmes (2004)

Proposals

- To eliminate the so-called "meter-based" grants for students from outside the EU/EEA and to implement tuition fees
- To establish a scholarship scheme for highly qualified students from countries outside the EU/EEA




Bill 2005

- Elimination of "meter-based" financing of programmes for students outside the EU/EEA. PhD programmes not be affected
- Implementation of 2 scholarship schemes
 - Academy profession programmes/Professional bachelor programmes
 - University Bachelor's and Master's programmes for students enrolled in a full degree programme – Cost neutral
- Decentralised administration and possibility of charging tuition fees higher than the actual expense
- Act effective in August 2006




Number of full-degree students – international students in Denmark and Danish students abroad






Student mobility, incoming and outgoing

study periods and traineeships






Number of international students by area of origin





Admission of international students distributed by area of origin, 2005-2012





- New demands on financial capacity
- "The shock-effect"
- Competition

Followed by a significant rise because of

- Consolidation in the market
- Scholarships
- Marketing
- Better introduction of the students
- More international programmes



"Denmark – an attractive study destination"

Action plan for strengthening the internationalisation of higher education II, April 2014

Vision

To **attract** and educate the most talented people from all over the world – and to **retain** them in Denmark after completing their studies

Problem

Fewer and fewer young people from countries outside Europe studying in Denmark

Goal

20 pct. of the new international students from outside the EU/EEA by 2020 (in 2012: 12 pct.)



Initiatives

- New grant programme
- Collaboration with private foundations and businesses
- Expansion of the "Study in Denmark" website
- Summer school courses
- Adjustment of grants for courses in Denmark under the Cultural Agreements Programme
- Easier access to apply for student resident permits



Perspectives

Tuition fee for international students opens the door for tuition fees for Danish students

Still a challenge to attract students outside the EU/EEA to Denmark – but we keep on trying!

- Ambitious 2020 goal
- The initiatives in "Denmark an attractive study destination"
- New study on educational export within higher education to be published soon
- Nordic Council of Ministers: Conference in the autumn 2015 on educational export
